This responds to your Freedom of Information Act (FOIA) appeal of the FOIA Officer's denial of your January 23, 2020 FOIA request for certain investigative records concerning Wirecard AG/ADR that the Commission has generated since January 23, 2018. By letter dated January 28, 2020, the FOIA Office informed you that it could not locate any responsive records. On March 19, 2020, you filed this FOIA appeal challenging the adequacy of the FOIA Office's search. I have considered your appeal and it is denied.

The FOIA requires agencies to conduct a reasonable search for records responsive to a request. A reasonable search is one that is calculated to locate responsive documents. The question raised by a challenge to the adequacy of a search is "whether the search was reasonably calculated to discover the requested documents, not whether it actually uncovered every document." [T]he adequacy of a FOIA search is generally determined not by the fruits of the search, but by the appropriateness of the methods used to carry out the search." Further, "there is no requirement that an agency search every record system."
